1.	If a partner or associate is a network, are the organizations who are members of the same network eligible recipients of sub-grants from the projects?	No. The grant beneficiaries may award financial support (sub-grants) to third entities (the sub-grantees). Sub-grantees are neither partners nor associates nor contractors. Subgrantees must be CSOs operating in the Republic of Serbia. (Guidelines for applicants 2.1.2, page 7).
2.	Is the organisation eligible if it is a limited liability company of non-profit character, founded by local self-governments and representatives of business and NGO/CSO sector, whose activities are coherent with the objectives of the Call?	 Any civil society organization meeting the criteria defined in sections 2.1.1 of the Guidelines for Applicants (p. 6) is eligible to apply as applicant. For the eligibility of partners, please see section 2.1.2 of the Guidelines for applicants. "In the interest of equal treatment of applicants, the Contracting Authority cannot give a prior opinion on the eligibility of an applicant, a partner, an action or specific activities." (Guidelines for Applicants, section 2.2.4, p.12).

18.	What exactly is meant by the grass-root organizations (their legal status and annual budget)?	Grassroots organizations are those organisations based in communities at the local level. With regards to their legal status, they should comply with the eligibility criteria set in point 2.1.1 of the Guidelines.

After consultations with the Tax Administration and the Office for Cooperation with Civil Society we will define the mode of VAT exemption and we will promptly inform the organizations whose projects are approved. 46.	Is the amount of sub-grant exempt from VAT? Namely, does the applicant transfer the whole sub-grant amount to rural CSO, or pays for its expenses for action from its account?	Please see answer 19. The modalities of payments should be settled between applicant and sub-grantee.
47.	Please clarify if an Italian no-profit working cooperative acting on themes relevant to such Call for Proposals is eligible as partner organization of the action.	Please see answer no. 2.
48.	Could one organization be at the same time a partner and the main applicant of two projects?	An applicant can be the main applicant on one project and a partner on the second. An organization can be a partner on maximum two projects (Guideline for applicants section 2.1.3 page 9).
49.	It has been said that a project theme could be research and dissemination of information. Can the project be designed in such a way that in the first six months research is carried out, and that the further activities depend on the results of that research?	The Contracting authority can not give a prior opinion an action or specific activities." (Guidelines for Applicants, section 2.2.4, p.12).
50.	Is it technically possible to conceive that kind of project?	Please see answer no. 49.
51.	Could a project proposal be a way to establish regional cooperation/partnership with border municipalities in Montenegro or is the call only related to Serbia?	Regional cooperation and good relations with neighboring countries are one of the project themes. Please see also answer 34.
52.	Is it allowed, with this call, that part of the activities takes place outside the territory of the Republic of Serbia?	Please see answer no. 34.
53.	Can local authorities be partners in the project and could the financial participation of the local self-government be shown as a contribution?	Please see answer 2. Financial contributions (co-financing) of applicants can be from any source except EU funds.

Funds do not need to be transferred to a separate account, but there must be proof of financial flow and evidence that the partners/associates resources are spent for the project realization.
67.	Is it necessary to submit a letter of intent when applying to the contest?	No. The application form itself contains a statement of partnership (partnership statement).
68.	Is there a possibility of linking project proposals in this competition with some other EUD programs in financial and program terms?	In financial terms it is not possible, but in program terms it is possible (for example, exchange of knowledge and experience). Please see also answer 106.
69.	Is there a limit to the percentage of funds allocated for financing the construction of the facility?	Since the projects within this competition can last from 12 -18 months, you may get into a situation, due to the tendering procedures for procurement of works, that you will not be able to realize the activities for which this program is primarily intended. 70.	Once we have planned the activities, since when we could expect/plan the realization of the project, if they are approved?	Please refer to section 2.5.2 of the Guidelines for applicants. This table is indicative.

When filling out the application, in one part of the application the applicant has to fill in all the previous projects. It is important to indicate which projects are implemented by now, the amount and the donor etc.
72.	For organizations that were registered and re- registered after the new law, and now re-enter the registration process, they have experience, but they cannot prove it. How could they apply?	Previous experience of organization should be presented in the application form.
73.	Is there a financial minimum, so that an association can apply for 50.000 EUR?	There is no minimum required for financial capacity of the applicant, but usually it is beneficial for the proposal if applicant's financial capacity is comparable to the budget of the proposed action. Please see also answer 55.
74.	In the case of networks, is it necessary for them to be formal or could they be informal too?	The applicants/partners must be legal persons.
75.	Regarding the term of less developed areas, are those some specific areas in Serbia, ie. which are the undeveloped areas?	The undeveloped areas are not defined in this call for proposals.
76.	As a relatively young organization we would chose sub-grants of 10.000 EUR. Does the grant of 10.000 EUR require additional support, ie. share of 10%?	Please note that sub-grants will not be managed by the EU Delegation but by the organizations which will apply for Theme 2.

Subgrants must not be the main purpose of the action.

The Contracting Authority does not have any influence on the distribution of the funds between the parties of a grant agreement. The EU will transfer the funds to the applicant which has all legal obligations regarding the grant agreement. Applicants must be directly responsible for the preparation and management of the action with their partners, not acting as an intermediary. Applicants' partners participate in designing
