Project title: "Collection, export and disposal of accumulated pharmaceutical waste from healthcare facilities"

No	Question	Answer
1	Can you list all the locations where the waste is located?	The waste is located throughout Serbia and stored at the premises of more than 300 healthcare institutions (clinics, hospitals, clinical centres, institutes of public health and veterinary institutes).
2	Can you give us information about the amounts of waste on these locations?	Waste amounts stored vary per location from a few kilograms to more than 10 tonnes.
3	Do you have list of waste with all the details?	Some healthcare institutions have detailed lists of the types and amounts of waste stored on the premises but for most locations such information does not exist or exists only partially.

4	Do you have information about the structure of the waste? (percent of each EWC codes in the waste)	Most of the waste can be classified as EWC 18.01.09, less than 10% can be classified as EWC 18.02.08. The waste includes code EWC 18.01.08* but this fraction is estimated to be less than 1% of the total. Furthermore, the waste may or may not be in its original packaging, it may be liquid or solid in nature and it may include aerosols, regulated substances, antibiotics, sera and vaccines.
5	Since the project is hazardous waste export from Serbia please advise if we are allowed to form Consortium with the legal entity registered abroad (considering they meet all the requirements).	Yes, this is allowed as long as all other requirements met, including eligibility requirements.
6	Are we requested and in which form do we present the subcontractor (waste incineration/treatment facility)?	In case incineration/waste treatment is sub-contracted, the subcontractor shall be named and an established relation between the tenderer and the sub-contractor shall be demonstrated, for instance in the form of a letter of intent.
7	Are we obliged to fulfil the table No 5 (FIELDS OF SPECIALISATION) from the application form?	Yes, as mentioned in the procurement notice, applications must be submitted using the standard application form, the format and instructions of which must be strictly observed.
8	Can you tell us more information regarding medical waste: what is the correct amount? 3,000 t as published or otherwise?	The amount of waste subject to this tender is 300 tonnes.
9	What is the dynamics of these quantity, will go as once or can be done several times?	It is up to the tenderer to propose how the waste will be exported.

10	Is it possible to obtain accurate data on the nature of waste, ISO code of waste?	Please refer to clarification number 4.
11	Please send to us list of locations from where should be waste medicaments collected	Please refer to clarification number 1.
12	Did ministries involved in this project (or other instances) plan to establish temporary warehouse for storage of the collected waste medicaments until export will be organized?	No, this is not foreseen by the authorities.
13	Please send to our e-mail list of the medicaments (type and quantities) with specification of locations where medicaments are in this moment.	Please refer to clarification number 1, 2, 3 and 4.
14	Is there any radioactive waste?	The pharmaceutical waste to be collected should not contain radioactive substances.
15	Regarding the subject contract please clarify requirement regarding average annual turnover of the company: is it necessary to exceed 1 mil EUR for the three years in total or for each year separately?	The average annual turnover refers to the turnover for one year.
