6. Description of the contract

Restoration of three buildings of the historical complex of Senjski Rudnik:

- The old mining company Administrative and shaft building (net inside area about 20 m²)
- The old Workshop with smithy building (net inside area about 435 m^2)
- The old Warehouse today a coal mine Museum building (net inside area about 580 m²).

Restoration works include, inter alias: new floors, new thermal insulations, reparation of doors, windows, roofs, painting of internal and external walls, new heating, water and sewerage system, construction of a new aluminium-glass construction entrance hall of 76 m² for the Workshop building and new addition to the Museum building of 160 m², new electricity and IT systems. Infrastructural works will include a new pipeline for water supply with fire fighting protection and a new heating pipeline connected to the existing boiler room.

8. Eligibility and rules of origin

In accordance with Article 168 of the Financial Regulation in the case of external actions, participation is open on equal terms to all legal persons participating either individually or in a grouping (consortium) or tenderers coming within the scope of the Treaties and, in accordance with the specific provisions of the basic instruments governing the cooperation sector concerned, to all such natural and legal persons who are nationals of the beneficiary third countries or of any other third country as are expressly mentioned in those instruments.

The tenderers from following countries should be eligible (based on Regulation No 2110/2005 on access to Community external assistance):

- Member States,
- Croatia, FYROM, Albania, Serbia, Montenegro,
- Iceland, Norway and Liechtenstein,
- Mexico and Chile through bilateral agreements.

9. Grounds for exclusion

Tenderers must submit a signed declaration, included in the Tender Form for a Works Contract, to the effect that they are not in any of the situations listed in point 2.3.3 of the **Practical Guide** to contract procedures for EU external actions.

10. Number of tenders

Tenderers may submit only one tender per lot. Tenders for parts of a lot will not be considered. Tenderers may not submit a tender for a variant solution in addition to their tender for the works required in the tender dossier.

11. Tender guarantee

Tenderers must provide a tender guarantee of **10,000 euros** when submitting their tender. This guarantee will be released to unsuccessful tenderers once the tender procedure has been completed and to the successful tenderer(s) upon signature of the contract by all parties.

12. Performance guarantee

The successful tenderer will be asked to provide a performance guarantee of 10% of the amount of the contract at the signing of the contract. This guarantee must be provided together with the return of the countersigned contract no later than 30 days after the tenderer receives the contract signed by the Contracting Authority. If the selected tenderer fails to provide such a guarantee within this period, the contract will be void and a new contract may be drawn up and sent to the tenderer which has submitted the next cheapest compliant tender.

14. Tender validity

SELECTION AND AWARD CRITERIA

16. Selection criteria

1) Economic and financial capacity

a) The average annual turnover of the tenderer in the past 3 years (2008, 2009 and 2010) must be at least the bid value.

b) The tenderer must have access to sufficient credit and other financial facilities to cover the required cash-flow for the duration of the contract. In any case, the amount of credit available must exceed the equivalent of at least EUR 150,000.

2) Professional capacity

a) The Tenderer (consortium as a whole or sole tenderer) must have the professional capacity to carry out at least 70% of the Contract Works by his own means, that is, he must have the equipment, materials, technical expertise, know-how and the human resources necessary to enable him to carry out this percentage of the contract. The remaining 30% of the works may be carried out by subcontractors nominated in the tender.

b) The lead member in a consortium/joint venture shall have the ability to carry out at least 50% of the contract works by its own means.

c) if it is a partner of a joint venture/consortium (i.e. not the lead member) it must have the ability to carry out at least 10% of the contract works by its own means.

d) Key personnel

The tenderer should include in the offer the list, the CVs and copy of diploma/degree of the following staff:

Project Manager shall possess qualification in engineering or closely related field plus 10 years of the experience in managing construction or refurbishment sites.

Civil engineer shall possess qualification in civil engineering plus 10 years of the experience in civil construction.

Quality Control responsible shall possess qualification in engineering or closely related field plus 5 years of the experience in quality control.

3) <u>Technical capacity</u>

a) The tenderer (consortium as a whole or sole tenderer) has successfully completed at least 2 projects of the similar nature and complexity (comparable to the works to be carried out under this tender) over the last 5 years (last 5 years shall be understood as the period of 1^{st} January 2006 up to the deadline for submission of tenders). The minimum value of each works contract should be of Euro 500,000, with the candidate proportion for works in each contract at or greater than Euro 350.000.
