Minutes of the Site Meeting and the Visits

- 1. In total 6 Companies signed their participation to the meeting and the site visit (List is annexed to the present minutes).
- 2. On behalf of the Beneficiary, the participants of the meeting were welcomed by Mr Ljubisa Dobrosavljević (Deputy President of the Municipality of Despotovac) and Mr Goran Bojić(General Manager of Public Entreprise Underground Coal Exploitation Resavica), who presented the historic background of the municipality and the region, while underlining the importance of the present project for the improvement of the economical conditions of the area. The project will contribute to the development of sustainable tourism and the tourist offer connected with the other important places in the region, Monasteri's Ravanica and Manasija, Resava Cave, waterfall Buk and other.
